Extremism

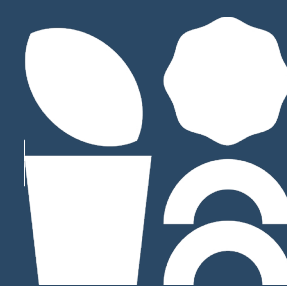
This is when someone has an extreme viewpoint and recruit others to enlist them into a similar way of thinking. The home office has recently created additional training on this (2022)

Fear Fear has a big impact on all things Safeguarding whether it be an abuser using fear as a weapon, someone who needs safeguarding that demonstrates fear, or someone who has concerns relating to safeguarding that is fear of repercussions. You can also call childline, NSPCC, or Crimestoppers.

Unexplained injuries should always be queried. You should always record accidents that happen in their setting; even if the child says that they are fine as sometimes children act brave or their adrenaline is masking the pain.

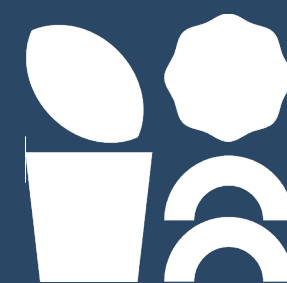
Lone working

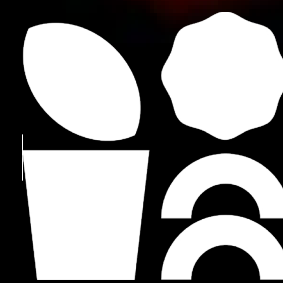

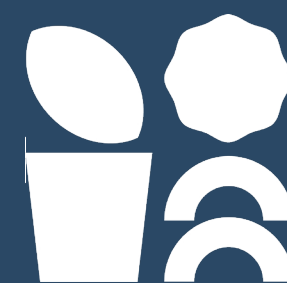

Questions

It is important that you do not ask leading questions though; safe questions are what happened next, or can you tell me more).

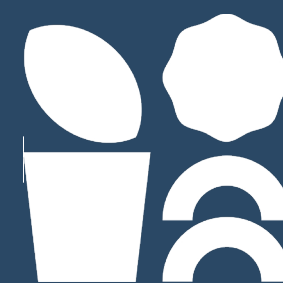

Victims

Victims of abuse can also be perpetrators of abuse acts due to coercion. Some abuse starts by the perpetrator abusing the child remotely. When the abuser becomes bored of the images from the child, they manipulate said child to collect images on their behalf.
