Reviews

These are ongoing and essential as part of the qualification and will be undertaken monthly by the Training Officer who will come out to see the learner in the setting. Reviews as well as being mandatory due to funding requirements are also a valuable opportunity for the Training Officer, learner and employer to meet and discuss progress made, challenges and forward planning. Reviews will cover all areas of the qualification including:

- the main Playwork qualification,
- essential skills or numeracy and literacy development,
- learner health and wellbeing,
- safeguarding topics,
- training undertaken
- as well as wider skills development and interests.

Reviews **must** be signed and commented on, promptly, on the day completed by Training Officer, learner **AND** employer, this then agrees all actions and provides an opportunity for two-way feedback. When reviews go unsigned funding can be withdrawn and the qualification terminated.

Adolygiadau

Mae'r rhain yn rhan barhaus a hanfodol o'r cymhwyster, ac fe'u cynhelir yn fisol gan y Swyddog Hyfforddi a fydd yn dod allan i weld y dysgwyr yn lleoliad. Mae adolygiadau, yn ogystal â bod yn orfodol oherwydd y gofynion ariannu, hefyd yn gyfle gwerthfawr i'r Swyddog Hyfforddi, y dysgwr a'r cyflogwr i gyfarfod a thrafod y cynnydd a wnaed, yr heriau a'r cynllunio i'r dyfodol. Bydd yr adolygiadau'n cwmpasu pob maes o'r cymhwyster, yn cynnwys:

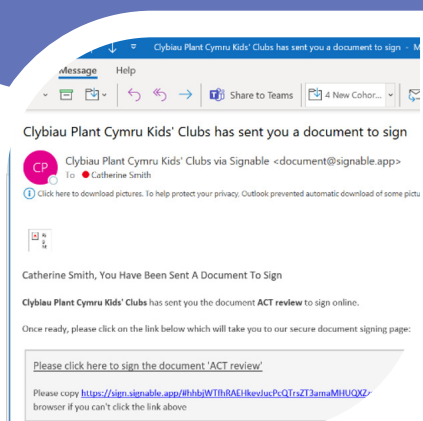
- y prif gymhwyster Gwaith Chwarae,
- y sgiliau hanfodol neu ddatblygiad rhifedd a llythrennedd,
- iechyd a llesiant dysgwyr
- pynciau diogelu
- yr hyfforddi a wneir
- yn ogystal â datblygiad sgiliau ehangach a diddordebau.

Rhaid llofnodi adolygiadau a **rhaid** eu bod wedi derbyn sylwadau, yn brydlon, ar y diwrnod y'u cwblhawyd gan y Swyddog Hyfforddi, y dysgwr **A'R** hyfforddwr; mae hyn yn arwydd o gytundeb â'r holl gamau a gymerwyd ac yn rhoi cyfle am adborth o'r ddau gyfeiriad. Os nad yw adolygiadau wedi'u llofnodi gellir tynnu'r ariannu yn ôl a rhoi terfyn ar y cymhwyster.



Signable

New Welsh Government initiative now requires from 1st August 2022, that all paperwork be completed electronically. Clybiau Plant Cymru Kids' Clubs has invested in Signable as a method of doing this. Signable is an online secure platform that sends an "envelope" containing the Individual Learning Plan (ILP) to all parties to be signed electronically. If you or your employee are doing their apprenticeship via our partnership with ACT the review will also be completed using signable. Below is an example of what an email may look like from signable.

iPEGS

For those learners undertaking their qualification and signed up with Cambrian Training, iPEGS is the secure platform that is being used. Sign up, health and safety monitoring, Progress Achievement Record (PAR - Reviews) and change of circumstance forms will all be completed online via the platform and will need to be signed by the Training Officer, learners and employers. Dates for signing will be set and reminders can also be given.

For signups it is vital that all documentation is gathered prior to the date due to sign up including information to support with completing the health and safety monitoring. All learners and employers will have to register as a user of iPEGS so that you are able to sign in to the platform to comment and sign off documents.

iPEGS

I'r dysgwyr hynny sy'n ymgymryd â'u cymhwyster ac wedi cofrestru gyda Hyfforddiant Cambrian, iPEGS yw'r platform diogel sy'n cael ei ddefnyddio. Caiff y cofrestru, y monitro iechyd a diogelwch, y Cofnod Cyflawni Cynnydd (CCC[PAR]) a'r ffurflenni newid amgylchiadau oll yn cael eu cwblhau ar y platform ar-lein a bydd angen iddynt gael eu llofnodi gan y Swyddog Hyfforddi, y dysgwr a'r cyflogwyr. Pennir y dyddiadau llofnodi a gellir rhoi atgoffiadau yn ogystal.

Yn achos cofrestru y mae'n hanfodol bwysig bod yr holl ddogfennau'n wedi'u casglu ynghyd cyn y dyddiad a fydd wedi'i bennu ar gyfer cofrestru; hyn i gynnwys gwybodaeth i gefnogi'r monitro iechyd a diogelwch. Bydd yn rhaid i bob dysgwr a chyflogwr gofrestru fel defnyddiwr iPEGS er mwyn i chi allu cofrestru ar y platform a llofnodi bod dogfennau wedi'u cwblhau.



Ecordia

Ecordia yw platform e-bortffolio ar-lein Clybiau Plant Cymru Kids' Clubs, a ddefnyddir i uwchlwytho'r holl dystiolaeth, ac i'r Swyddog Hyfforddi ei ddefnyddio i roi adborth i'r dysgwr ac olrhain y cynnydd a wnaed. Rhoddir manylion mewngofnodi i bob dysgwr i'w galluogi i gyrchu eu portffolios, a gellir gwneud hyn nail ai drwy wefan ecordia neu drwy eu ap. Bydd hefyd angen i ddysgwyr dderbyn adborth a llofnodi yn erbyn unedau a gwblhawyd er mwyn dangos y cynnydd ar ecordia. Anfonir e-byst atoch i roi gwybod i chi y bydd angen gweithredu ar hyn, neu gallwch ddod o hyd i hyn yn adran dasgau eich tudalen hafan ar ecordia.

Ecordia

Ecordia is Clybiau Plant Cymru Kids' Clubs online e-portfolio platform that is used to upload all evidence and for the Training Officer to provide feedback to the learner and track progress made. All learners will be provided with a log in to access their portfolios and this can be done either through ecordia's website or through their app. Learners will also need to accept feedback and sign off units to show progression on ecordia, you will be sent emails to let you know this needs to be actioned or you can find it on the task section on your ecordia homepage.

Terminolegy Maes

Atal dros dro - gallai fod adegau'n deillio o amgylchiadau personol neu salwch pan fydd angen atal dysgwr dros dro. Bydd hyn yn golygu rhoi terfyn dros dro ar y dysgu a gall bara am hyd at 13 wythnos. Trafodir ataliad-dros-dro dysgwr gyda'r Swyddog Hyfforddi, y cyflogwr a'r Rheolwr Hyfforddiant Cenedlaethol i weld hefyd a oes angen rhoi unrhyw gefnogaeth ychwanegol yn ei lle.

PECYN CYMORTH SGILIAU HANFODOL CYMRU -

dyma system sydd wedi'i dylunio yn gyntaf i asesu lefelau sgiliau dysgwyr mewn rhifedd a llythrennedd er mwyn rhoi i Swyddogion Hyfforddi ddarlun clir o ba gefnogaeth neu addasiadau y bydd eu hangen, ac yn ail fel platfform y gall dysgwyr ei ddefnyddio i adeiladu ar sgiliau a chynyddu hyder a lefelau.

SHC - sef Sgiliau Hanfodol Cymru, sy'n cyfeirio at y cymwysterau rhif a chyfathrebu sy'n rhan o gwblhau'r brentisiaeth. Oni bai eich bod yn gallu darparu tystysgrifau'n dangos eich bod wedi ymgymryd â chymhwyster SHC neu TGAU (mewn Mathemateg, Saesneg neu Gymraeg) mae'n ofynnol i bob dysgwr ymgymryd â'r sgiliau hyn yn llwyddiannus er mwyn cwblhau eu prentisiaeth. Bydd angen i ddysgwyr Lefel 2 mewn Gwaith Chwarae gwblhau o leiaf Lefel 1 SHC, a bydd angen i ddysgwyr Lefel 3 a Lefel 5 mewn Gwaith Chwarae gwblhau o leiaf Lefel 2 SHC.

Terminology of the Quarter

Suspension - there may be times due to personal circumstances or illness that a learner will need to be put into suspension. This means a temporary stop on learning and can last for up to 13 weeks. Suspension of a learner is discussed with the Training Officer, employer and learner as well as the National Training Manager to also see if any additional support is needed to be put into place.

WEST - stands for the Wales Essential Skills Toolkit and is a system designed to firstly assess learners' skills levels in numeracy and literacy in order to give Training Officers a clear picture as to what support or adaptations may be needed and secondly as a platform that learners can use to build on essential skills and increase confidence and levels.

ESW - stands for Essential Skills Wales and refers to the application of number and communication qualifications that are part of completing an apprenticeship. Unless you can provide certificates of previously undertaking an ESW or GCSE (Maths, English or Welsh) qualification all learners are required to undertake these skills to successfully complete their apprenticeship. Level 2 Playwork learners will need to complete Level 1 ESW as a minimum, and for Level 3 Playwork and Level 5 Playwork learners a minimum of Level 2 ESW need to be completed.



Expectations of learners at Level 2 & Level 3

In order to be assessed at that standard the apprentice needs to be given opportunities to gain experience at that level and take responsibility at that level, along with mentoring, advice and reflection to help them improve.

At Level 2

Your employees should be demonstrating skills related to playwork practice and appropriate responses and relationships with children as well as good team working and reflection.

At Level 3

Your employees at this level should be demonstrating skills that would satisfy the assessor that they could take responsibility as Person in Charge of a club. Learning and work opportunities should reflect this level of competence and responsibility and they should be acting the role of person in charge during assessment.

Referencing

Whichever level qualification you are undertaking, referencing and evidence of further reading and research is important to evidence and strengthen your work.

At **Level 2** it is **desirable** that you include references and a bibliography in your work

At **Level 3** and **Level 5** it is **essential** that you show wider reading and research by including quotes and references in your work as well as a bibliography.

This also includes referencing and using quotes as part of any discussions that should be planned and prepared for. Whilst research and use of references is important it is also vital that you make it clear where any references have come from so that it shows clearly your own work and that it isn't plagiarised and being passed off as your own.

References not identified could be considered plagiarism and will need to be reported to NCFE as the awarding body.

For support with how to reference your work, please refer to the full Referencing and Bibliography Guide and also speak to your Training Officer for support.

- Mae gan ddysgwyr ar Lefel 3 15 mis o'u cofrestru i gwblhau eu cymhwyster
- Mae gan ddysgwyr ar Lefel 5 24 mis o'u cofrestru i gwblhau eu cymhwyster

Our learner surgery completed recently showed that not all learners are aware of when their end date is. We are making changes to sign up and how this is communicated so that learners are aware of end dates that they need to work towards. From the moment learners are signed up:

- Level 2 learners have 12 months from sign up to complete their qualification
- Level 3 learners have 15 months from sign up to complete their qualification
- Level 5 learners have 24 months from sign up to complete their qualification
