

Aros I Chwarae, Cardiff: Supporting a club to become a Charitable Incorporated Organisation (CIO)

Aros I Chwarae After School Club, operate from Ty Gwyn School in Ely, Cardiff.

The Chairperson Debbie contacted Clybiau Plant Cymru Kids' clubs on several occasions for various support. Through previous conversations with Clybiau Plant Cymru Kids' Club the committee decided they would like to become a Charitable Incorporated Organisation (CIO) to offer limited liability to members as well as the ability to apply for charitable funding. Becoming a CIO is important as the club supports children with complex needs, so funding is vital to ensure that they have all the equipment and specialist care they need. It will also give the club financial sustainability in the years to come if they can access grant funding.

Debbie was unsure of the process and contacted the Childcare Business Development Officer for advice on what they would need to do to become a CIO. The support was well received from Debbie;

'Our Regional Childcare Business Development Officer gave me details of the process, she came to the club to talk it through, supported me through emails and checked in regularly to see if I needed further help. I had another large project that was taking all my time and this fell to the back of my priorities, I explained to her I was lost and overwhelmed and she came in again and brought all the paperwork, explained it all, had a detailed 'Action plan' of each stage.. When I finished the constitution our Childcare Business Development Officer looked through it, suggested amendments and revisited the next steps. With the support given the club became a CIO in September 2023. The plan is to eventually register with CIW, where we will use Clybiau Plant Cymru Kids' Clubs invaluable support again.'

'The support given was priceless, I had an action plan to follow with all the links I needed. If I was unsure our Childcare Business Development Officer was always available for a visit, phone call or via email. Aros I Chwarae, Caerdydd: Cefnogi clwb i ddod yn Sefydliad Corfforedig Elusennol (SCE)

Mae Clwb Ôl-ysgol Aros i Chwarae yn gweithredu o Ysgol Tŷ Gwyn yn Nhrelái, Caerdydd. Cysylltodd y Cadeirydd, Debbie, â Clybiau Plant Cymru Kids' Clubs sawl gwaith am wahanol fathau o gefnogaeth. Trwy wahanol sgyrsiau blaenorol â Chlwby Plant Cymru Kids' Club penderfynodd y pwylgor eu bod am ddod yn Sefydliad Corfforedig Elusennol (SCE) er mwyn cynnig atebolrwydd cyfyngedig i aelodau yn ogystal â rhoi iddynt y gallu i wneud cais am arian elusennol. Mae dod yn SCE yn bwysig gan fod y clwb yn cefnogi plant ag anghenion cymhleth, felly mae cyllid yn hanfodol i sicrhau bod ganddynt yr holl offer a'r gofal arbenigol sydd eu hangen arnynt. Bydd hyn hefyd yn rhoi cynaliadwyedd ariannol i'r clwb yn ystod y blynnyddoedd i ddod petaent yn llwyddo i gael mynediad at gyllido grant.

Roedd Debbie yn ansicr o'r broses a chysylltodd â'r Swyddog Datblygu Busnesau Gofal Plant i gael cyngor ar yr hyn y byddai angen iddynt ei wneud i ddod yn SCE. Roedd Debbie'n falch iawn o gael y cymorth:

"Rhoddodd ein Swyddog Datblygu Busnesau Gofal Plant Rhanbarthol fanylion y broses i mi, daeth i'r clwb i'w trafod, fy nghefnogi trwy e-byst a'm e-bostio'n rheolaidd i weld a oeddwn angen cymorth pellach. Roedd gen i brosiect mawr arall a oedd yn cymryd fy holl amser ac roedd hyn yn disgyn i waelod fy rhestr blaenoriaethau i. Esboniai wrthi fy mod ar goll ac wedi'm llethu, ac fe ddaeth i mewn ataf eto gyda'r holl waith papur, egluro'r cyfan; roedd ganddi 'Gynllun Gweithredu' manwl o bob cam. Pan orffennais y cyfansoddiad edrychodd ein Swyddog Datblygu Busnesau Gofal Plant drwyddo, awgrymu gwelliannau ac ailedrych ar y camau nesaf. Gyda'r gefnogaeth a roddwyd daeth y clwb yn SCE ym mis Medi 2023. Y cynllun yn y pen draw yw cofrestru ag AGC a defnyddio cefnogaeth amhrisiadwy Clybiau Plant Cymru Kids' Clubs unwaith yn rhagor."

"Roedd y gefnogaeth a roddwyd yn amhrisiadwy, roedd gen i gynllun gweithredu i'w ddilyn gyda'r holl dolenni cyswllt yr oeddwn eu hangen. Os oeddwn yn ansicr roedd ein Swyddog Datblygu Busnesau Gofal Plant bob amser ar gael i ymweld, ar gael dros y ffôn neu drwy e-bost. Rwyf bob amser wedi argymhell Clybiau Plant Cymru Kids' Clubs i lawer o wasanaethau gan fy mod wedi cael cymorth a chefnogaeth amhrisiadwy ganddynt ers i mi ddechrau 11 mlynedd yn ôl.'

'Roedd y cymorth busnes wedi'i deilwra a roddwyd drwy Brosiect Loteri Genedlaethol Clybiau Plant Cymru Kids' Clubs yn atgyfnerthu llywodraethiad y lleoliad gan i'r pwylgor rheoli ennill atebolrwydd cyfyngedig i'w haelodau, ac ar yr un pryd ddarparu cynaliadwyedd ar gyfer y dyfodol.'
